

## KMAP 2016 Data Reporting & Collection Policy

Participation in the optional 12 month data reporting program requires Keurig Authorized Distributors (KADs) to share end user K-Cup® pack and Bolt® pack sales data with Keurig Green Mountain, Inc. (Keurig), beginning on the date the Keurig® KMAP brewers are installed.

End User Pack Sales Data Requirements:

#### **KMAP Standard Information**

- KMAP Approval #
- End user location contact information
- Workplace size, including # of employees, break rooms, locations
- Brewer types placed

### **Data Reporting Information**

- Duration: 12 months
- Pack Sales: Number of unique SKU units sold by Brand, Product Name, Product Part #
- Location Data: End User "Ship To" information
- Standard file format for reporting data must be used

By agreeing to the below terms and conditions, KADs will exclusively provide proprietary data to Keurig which will be housed by data collection agency, Blue World, Inc. (the DCA). This data will be used only for Keurig internal purposes and it will not be shared with any other Keurig Authorized Distributor. Blue World Inc. is the authorized data collection agency for Keurig. In exchange for this participation, the KAD will receive an additional 25% rebate (on top of the 75% Rebate) of the cost of the Keurig® KMAP Brewer installed at the approved workplace location. Once a KMAP rebate is paid in full to the KAD, Keurig will not request any form of reimbursement if the end user location generates lower than expected K-Cup® pack and Bolt® pack sales.

- Payments will occur on the 15<sup>th</sup> of every month following the end of the quarter (April/July/October/January)
- In order to qualify, data needs to be uploaded within the first ten business days of each quarter for a 12 month period



- Failure to meet deadlines may result in suspension or termination of future payments
- If more than one unique KMAP rebate (by KMAP Approval #) are claimed by a single KAD, payment sums will aggregate with previous submissions. If there are multiple rebate claims for unique KMAP, applied over a period of time (months), those rebates will be paid by the predetermined quarterly amount as long as end user KMAP location data is reported as agreed upon. Reference the terms and conditions for details
- Data will be shared in (.csv) format to be uploaded to Keurigpromo.com. The csv file template will be provided for reference on Keurigpromo.com.
- Non-compliant file formats will not be accepted
